AGREE TO PARTICIPATE AND LIABILITY WAIVER - I understand it is my responsibility as an adult participant or parent not to participate or allow participation if there are any physical, emotional and behavioural or other problems that might compromise safe involvement. I expressly agree and promise to accept and assume all of the risks existing in this activity as listed below.

I understand that sports activities including dance and acrobatics involve risk and possible injury, including but not limited to emotional distress, damage to myself, to property, or to third parties and in severe cases paralysis and death.

My participation or my child's participation in this activity is purely voluntary, no person(s) are forcing me or my child to participate and I elect of my own volition to participate or have my child participate with full knowledge of the risks involved.

I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Northern Diamonds Academy of Dance Inc., its instructors, employees, and associates, from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with my participation or my child's participation in this activity.
